Instructions for Poster Presentation

- Posters should be prepared in PORTRAIT format and with presentation text in English. A board of 1 meter in height and 1 meter in width will be made available for each paper.
- The title of poster should cover full width of the poster; bold letter Times New Roman and font size 14 should be used. Letters must be readable from a distance of 3 feet.
- The name(s) of the author(s), address (es) should be written below the title in small letters.
- Figures and diagrams must be simple and self explanatory.
- Corresponding authors will be notified about the day, time, and venue for the display. The presenting author must be present during display of the poster.
- One author can present only one poster.
- Abstracts not complying with any of the above conditions will not be accepted.

CALL FOR ORAL PRESENTATION

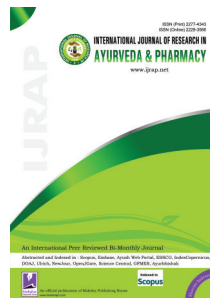
- Topic should be relevant to the thrust area given for poster presentation.
- Topic presented by the presenting author should be his own research work.
- Eligibility: Ph.D. or Ph.D. pursuing.

CALL FOR FULL LENGTH MANUSCRIPT

- Selected No. of original research work will be published in any of the mentioned Scopus indexed journals (JAPTR: 05, IJRAP=10 and IJPPS=10)
- Authors are requested to provide following information in covering letter along with their manuscript.
 1. Novelty of work
 2. Similarity index report (less than 20%)
 3. Name of most preferred journal (JAPTR, IJRAP and IJPPS)
 4. Manuscript should be exactly in the format as per the Journal's instruction to the authors.

- The abstract (250 words max.) for poster and oral should be submitted as per the template given on website and must be mailed to icpscscientific@gmail.com (+91-9872260354).
- The decision of the Scientific Committee shall be final.
- Last date for acceptance of abstract for poster, oral, and full length manuscript is 25th March 2017. The author(s) will receive communication regarding acceptance of their submission(s) by 30th of March 2017.
